



Prince of Songkla University Announcement

Title: Health Care Service and Personal Accident Insurance for International Students

In order to provide an expedient and effective health care service and accident insurance (group) for Prince of Songkla University international students, the services are specified as follows:

Section I

Health Care Service and Personal Accident Insurance (Group) for
Students with ID 54., 53., 52., 51..

1. To have the rights to obtain health care services, PSU students, must enroll according to the PSU regulations, have already paid the tuition fee for the first semester, and maintain their student status.

2. Those who have the right to obtain health care services, including medical and dental services must do so at the hospitals specified by each campus.

3. The students, as mentioned in item no.1, have to give their consent to the doctor or the hospital staff to provide health care information to the university officials in order to be granted the right to obtain the medical services.

4. The right to obtain health care services according to this announcement applies to basic medical services and does not cover the following medical care:

4.1 plastic surgery

4.2 private room fee

4.3 special nursing service

4.4 special and expensive drugs, and drugs which are not on the hospital list;

however, this should be according to the doctor's advice

4.5 doctor fees from an evening clinic or from a private hospital.

4.6 congenital diseases, pregnancy care, prenatal care, abortion and baby delivery

4.7 medical certificate, not related to a sickness

4.8 physical check-up

4.9 cosmetic surgery

4.10 other fees

5. The university has made available personal accident insurance (group) for all international students. The international students who have enrolled and paid the tuition fee and maintain their student status, have the right to obtain medical care and be covered by the accident insurance throughout the academic year as shown in the contract.

6. The students, as mentioned in item no.5, are entitled to accident insurance coverage from all government hospitals, private hospitals, polyclinics, and clinics with licensed doctors worldwide.

Section II

Health Care Service and Personal Accident Insurance (Group) for
Students with ID 55., 56..57... and more


7. The university provides health and accident insurance via an insurance company for students with ID 55...and more, who have already enrolled and paid the tuition fees for the first semester, in order to obtain services from hospitals. The university provides only basic medical care as specified by each campus.

8. The students who have the right according to item no.7 have to give their consent to the doctor or the hospital staff to provide health care information to the university officials in order to obtain the services.

9. The university has made available personal accident insurance (group) for all international students with ID 55...and more. The international students who have enrolled and paid the tuition fee and maintain their student status, have the right to obtain medical care and be covered by the accident insurance throughout the academic year as shown in the contract.

10. The PSU President authorizes the Vice President for Student Affairs to adjudicate the right to obtain health care and accident insurance for international students and to consider any questions related to this announcement.

Section I

Health Care Service and Personal Accident Insurance (Group) for
Students with ID 54., 53., 52., 51..

1. To have the rights to obtain health care services, PSU students, must enroll according to the PSU regulations, have already paid the tuition fee for the first semester, and maintain their student status.

2. Those who have the right to obtain health care services, including medical and dental services must do so at the hospitals specified by each campus.

3. The students, as mentioned in item no.1, have to give their consent to the doctor or the hospital staff to provide health care information to the university officials in order to be granted the right to obtain the medical services.

4. The right to obtain health care services according to this announcement applies to basic medical services and does not cover the following medical care:

4.1 plastic surgery

4.2 private room fee

4.3 special nursing service

4.4 special and expensive drugs, and drugs which are not on the hospital list;

however, this should be according to the doctor's advice

4.5 doctor fees from an evening clinic or from a private hospital.

4.6 congenital diseases, pregnancy care, prenatal care, abortion and baby delivery

4.7 medical certificate, not related to a sickness

4.8 physical check-up

4.9 cosmetic surgery

4.10 other fees

5. The university has made available personal accident insurance (group) for all international students. The international students who have enrolled and paid the tuition fee and maintain their student status, have the right to obtain medical care and be covered by the accident insurance throughout the academic year as shown in the contract.

6. The students, as mentioned in item no.5, are entitled to accident insurance coverage from all government hospitals, private hospitals, polyclinics, and clinics with licensed doctors worldwide.

Section II

Health Care Service and Personal Accident Insurance (Group) for
Students with ID 55., 56..57... and more

7. The university provides health and accident insurance via an insurance company for students with ID 55...and more, who have already enrolled and paid the tuition fees for the first semester, in order to obtain services from hospitals. The university provides only basic medical care as specified by each campus.

8. The students who have the right according to item no.7 have to give their consent to the doctor or the hospital staff to provide health care information to the university officials in order to obtain the services.

9. The university has made available personal accident insurance (group) for all international students with ID 55...and more. The international students who have enrolled and paid the tuition fee and maintain their student status, have the right to obtain medical care and be covered by the accident insurance throughout the academic year as shown in the contract.

10. The PSU President authorizes the Vice President for Student Affairs to adjudicate the right to obtain health care and accident insurance for international students and to consider any questions related to this announcement.
