In accordance with Article 3 of the Agreement, concluded on May 9, 1996 and subsequently extended on May 9, 2001, 2006 and 2011. Chiba University and Prince of Songkla University agree to extend the Agreement for 5 additional years, commencing on May 9, 2016. The agreement shall be automatically renewed for another 5 years unless either party undertakes in writing to withdraw from the agreement. A written declaration of withdrawal must be made no later than 6 months before the termination of a given 5- year program.

Article 8. Prospective exchange students must satisfy the language proficiency requirements of their course of studies, and must have completed at least one (1) year of continuous study at the sending university before being admitted to the exchange program. Prospective exchange students who apply to study at the graduate level must have completed at least one (1) semester of graduate studies before being admitted to the exchange program. Exchange students are expected to return to the sending university upon completion of the exchange program.

Article 9. The sending university will recognize credits, awarded by the receiving university according to the regulations and practices of the sending university.

Article 10. Each university will, within the limits of their resources, assist exchange students covered under the terms of this agreement in securing accommodations and in achieving their study and research goals.

Article 11. This agreement takes effect when it is signed by both parties. The agreement is to remain in effect for five (5) years from the date it is signed and shall be automatically renewed for another five (5) years unless either party undertakes in writing to withdraw from the agreement. A written declaration of withdrawal must be made no later than six (6) months before the termination of a given five (5) year program.

Article 12. The agreement may be modified by mutual written consent of both parties.

Article 13. The agreement may be terminated by either university with notification to the other party at least six (6) months prior to the effective date of termination. The termination of the agreement will not affect the terms of activities ongoing at the time of notification of termination unless otherwise agreed between the parties.
